PIERCE COUNTY BOUNDARY REVIEW BOARD
ASKING THE BOARD TO REMOVE FOX ISLAND
FROM THE PENINSULA METROPOLITAN PARK DISTRICT**

GOVERNING LAWS

RCW 36.93.100

**Review of proposed actions by board—Procedure.
(relevant provisions)**

The board shall review and approve, disapprove, or modify any of the actions set forth in RCW 36.93.090 when any of the following shall occur within forty-five days of the filing of a notice of intention:

(3) A petition requesting review is filed and is signed by:

(a) Five percent of the registered voters residing within the area which is being considered for the proposed action (as determined by the boundary review board in its discretion subject to immediate review by writ of certiorari to the superior court); or

(b) An owner or owners of property consisting of five percent of the assessed valuation within such area;

If a period of forty-five days shall elapse without the board's jurisdiction having been invoked as set forth in this section, the proposed action shall be deemed approved.

If a review of a proposal is requested, the board shall make a finding as prescribed in RCW 36.93.150 within one hundred twenty days after the filing of such a request for review. If this period of one hundred twenty days shall elapse without the board making a finding as prescribed in RCW 36.93.150, the proposal shall be deemed approved unless the board and the person who submitted the proposal agree to an extension of the one hundred twenty day period.

RCW 36.93.090

**Filing notice of proposed actions with board.
(relevant provisions)**

Whenever any of the following described actions are proposed in a county in which a board has been established, the initiators of the action shall file within one hundred eighty days a notice of intention with the board. The board may review any such proposed actions pertaining to:

(1) **The: (a)** Creation, incorporation, or **change in the boundary**, other than a consolidation, **of any city, town, or special purpose district;**

RCW 36.93.020

**Definitions.
(relevant provisions)**

As used herein:

(1) **"Governmental unit"** means...any special purpose district as defined in this section.

(2) **"Special purpose district"** means any...metropolitan park district...

The purpose of this Petition is to satisfy the requirement set forth in RCW 36.93.100(3)(a) or (b), quoted above. **Please see the Notice of Intention, attached hereto and incorporated herein by this reference, that will be filed along with this Petition with the Pierce Boundary Review Board.** If you agree that Fox Island should be removed from the Peninsula Metropolitan Park District, please sign and date this Petition and please make sure you include your address so Pierce County can verify, according to their records, that you are a Fox Island resident.
